Attachment 1 below is a time-depth curve for the well. Progress has not been as expected with rates of penetration slowed by the need to maintain angle and azimuth. It has been difficult to prevent "walking to the right" with lots of corrections being required hampering progress.

Note that the actual performance of Jacaranda Ridge 2 is included for reference. It should be noted that this well did not require the same level of directional control.

Target depth is now expected to be reached in the next 4 -5 days.


