Further to the announcement on 23 August 2010, the Company is pleased to announce that it has completed the first tranche of the capital raising and allotted 71,075,000 ordinary fully paid shares (**Shares**) at \$0.018 per Share, to raise \$1,279,350. Subject to shareholder approval, free attaching options exercisable at \$0.05 each on or before 31 December 2013 (**Options**) will be issued on the basis of one Option for every one Share subscribed for and issued.
