CLARIFICATION OF RELEASE – DR SEMKIWA'S ESTIMATE OF NGAKA COAL DEPOSIT

Atomic Resources Limited wishes to advise that the 800 million tonnes referred to in the ASX release dated 19th July 2010 was an exploration target and is not a resource estimate in accordance with the JORC Code. Further verification drilling is required to enable Atomic to determine the quality and quantity of coal in accordance with the JORC Code. Based on the drilling and test work previously completed potential coal tonnage target of between 600 to 800 million tonnes is anticipated. (*In accordance with Section 18 of the JORC Code Atomic advises that the quantity and quality of the coal at the NGAKA Basin is conceptual in nature. There has been insufficient exploration to define a Mineral Resource (in excess of the 210 million tonnes JORC code, and it remains uncertain that further exploration will result in an increase of the Mineral Resource.)*

The current JORC compliant resource stands at over 210 million tonnes of thermal coal. (Measured 118.39 mt, Indicated 25.49 mt and Inferred 68.82 mt - ASX announcement dated 29th September 2009) The Company anticipates receiving a JORC compliant resource update from recent drilling in the near future.
