**ISSUE OF ANATOLIA ENERGY LIMITED SHARES SECONDARY TRADING NOTICE  
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT  
2001 ("Act")**

The Board of Directors of Anatolia Energy Limited ("Company") is pleased to announce the allotment and issue on 15 December 2010 of 15,000,000 fully paid ordinary shares ("Securities") at an issue price of \$0.20.

**Secondary Trading Exemption**

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.


