#### **EASTLINK TRAFFIC AND REVENUE - SEPTEMBER 2010**

ConnectEast, owner and operator of EastLink, announces the following traffic and revenue information for September 2010.

### **Highlights**

- Average Daily Revenue (ADR) of \$607,227 for the month of September 2010 was the highest monthly ADR recorded on EastLink and was 13.2% higher than in September 2009.
- Average Daily Trips (ADT) of 181,102 in September 2010 was the highest monthly ADT recorded on EastLink and was 10.9% higher than in September 2009.
- Average Workday Trips (AWT) of 201,715 in September 2010 was the highest monthly AWT recorded on EastLink and was 11.5% higher than in September 2009.
- Commercial traffic growth continues with the number of LCV and HCV trips 19.5% and 15.9% higher in September 2010 respectively than in September 2009. HCV trips increased by 5.4% and LCV trips by 2.6% compared to August 2010.
- Continued strong growth on EastLink toll sections adjacent to and south of the Monash Freeway Interchange following the recent completion of the M1 Upgrade.
- ADR was 2.7% higher than in August 2010.
- ADT was 1.0% higher than in August 2010.
- AWT was 0.6% higher than in August 2010.
- Average Trip Toll increased to \$3.35 from \$3.30 in August 2010, consistent with the Victorian school holidays from 20 September 2010 to 3 October 2010.
