KINGAROY UNDERGROUND COAL GASIFICATION **PILOT PROJECT UPDATE**

- Installation of the new production wells complete
- Final site preparation work for re-ignition ongoing
- Recommencement of gasification process and gas production scheduled for the last week of July 2010

Cougar Energy Limited (ASX: CXY) advises that the installation of the two new wells P5 and P6 has been completed at the Company's Kingaroy underground coal gasification pilot project (refer to the Announcement to the ASX dated 2 July 2010).

Final site preparation work has commenced, involving assembling and testing of pipework and electrical systems, air injection testing for the new wells, and preparation of the coal seam prior to ignition. The current schedule forecasts re-ignition of the gasification process to commence in the last week of July 2010.

Upon completion of the settlement of the recent share placement, proceeds totalled AUD 1.23 Million after transaction costs, resulting in 17,775,408 fully paid ordinary shares being issued. A further Appendix 3B and the Section 708(5)(e) Notice (Cleansing Statement) will be lodged with the ASX later today.

Cougar Energy is also developing international projects with Direct Invest (People's Republic of China and Mongolia) and Cougar Energy (UK) Limited (47.8% owned).
