

- The exercise of Rights is contingent on Engin Limited achieving the agreed year-to-year targets for SIOs (Services in Operation) and EBITDA (effective for Tranches 2-4) (**Targets**).
- Vesting of Rights is contingent on ongoing employment
- The allocation of Rights for Tranche 1 is considered a “Performance Bonus” based on performance already achieved in the FY 09 year.
- Four tiers are used to measure performance for purpose of the vesting of Rights:

Achieving Target greater than or equal to:	100%
% of Rights that vest:	100%
Achieving Target greater than or equal to:	95-99%
% of Rights that vest:	75%
Achieving Target greater than or equal to:	90-94%
% of Rights that vest:	50%
