## **ENERJI ESTABLISHES PIPELINE OF COMMERCIAL OPPORTUNITIES**

## **Highlights:**

- Progress payments totalling \$1.7m made on six 3<sup>rd</sup> generation Opcon Powerboxes, securing delivery schedule commencing in December 2010
- 3<sup>rd</sup> generation technology specified and built to Australian standards and for Australian conditions
- Advanced negotiations underway with potential customers

Enerji Ltd ("**Enerji**" or the "**Company**") (**ASX: ERJ**) has made progress payments on six new 3<sup>rd</sup> Generation Opcon Powerboxes, securing the delivery schedule for the units. The progress payment means that the total program of six Opcon Powerboxes are now in the production pipeline.

The first unit is scheduled for delivery to Australia in December 2010.

The 3<sup>rd</sup> Generation Opcon Powerboxes are being specified and built to Australian standards and for Australian conditions.

Energi has the exclusive Australian sales and distribution rights to the proven Opcon Powerbox technology, which converts waste heat into green electricity. The Opcon Powerbox represents a significant commercial opportunity in Australia through application to industrial, mining and power generation operations.

Enerji Managing Director Greg Pennefather said the progress payments on the new units, totalling \$1.7million, established a pipeline of available units to align with commercial customer contracts.

"With the technology now refined for Australian standards and the delivery schedule for the new Opcon Powerboxes on schedule, the Board and management of Enerji is now focused on finalising commercial arrangements for the roll-out of the technology," he said.

"We are now in advanced negotiations with a number of industrial, power generation and mining companies for agreements for the installation of the units at their facilities.

"With the scale of some operations in Australia and annual production of around 6,400MWh per unit, there is potential for the installation of between 1 and 3 Opcon Powerboxes at each site. Installation of the technology would deliver significant benefits to clients, including savings on electricity generation, produce green power and, in some cases, support value adding industrial processes.



"With our first 3<sup>rd</sup> generation Opcon Powerbox, which will be arriving in Australia in December 2010, these additional Opcon Powerboxes will mean we are well placed to meet what we expect to be significant, long term demand for the technology."
