Market Update – Transition of Board including attached App 3X's (3) and App 3Z's (2)

Perth: Monday 22 March 2010 - The directors advise the market of the following changes in the company.

Board

In keeping with our commitment to transition the board more to ASX Principles of Good Governance, and, further to our announcement of 4 December 2009, we are pleased to announce the appointment of a new independent Non-Executive Chairman and two new independent non-executive directors. The search process has been led by an independent, professional group with demonstrable experience in this area.

Mr Byram Johnston OAM - Independent Non-Executive Chairman

Mr Johnston is a Fellow of the Institute of Chartered Accountants, CEO of MainstreamBPO, Board member of the Garvan Research Foundation, a Member of the ASIC Audit Committee as well as involvements on a number of other corporate and government boards and committees. He has previously been the Managing Partner, Arthur Anderson, Sydney and the Managing Partner Asia Pacific for PA Consulting Group and has a strong advisory and consulting background.

Byram has extensive commercial experience having worked in Japan, Korea, Taiwan, China, Hong Kong, Thailand, Philippines, Malaysia, India, New Zealand, and Fiji.

He brings to Greencap solid experience in public company boards, strong commercial skills and demonstrated strategic planning expertise. He is based in Sydney.

Mr Adrian Kloeden - Independent Non-Executive Director

Mr Kloeden was CEO of Serco Asia Pacific for five years to 2007 before being appointed Chairman of Serco Asia Pacific. From 2010 he is Chairman, Serco Asia Pacific Advisory Board. Prior to his Serco roles, he was CEO of Melbourne IT.

Mr Kloeden is a director of CEDA (Committee for Economic Development of Australia) and is involved with senior executive business coaching for large companies and professional services firms. Adrian is an experienced CEO with a demonstrable ability to deliver on high level performance and outcomes over a wide range of industries and in all major cultures and economies of the world. Mr Kloeden is based in Melbourne.

Mr Peter Martin - Independent Non-Executive Director

Mr Martin is a chartered accountant and has an MBA. He recently held senior positions with Royal Main Holdings plc and media group - PMP Limited. Prior to that he held positions with KPMG, Gresham Partners and Hansen Plc.

Peter has a strong background in strategy, corporate development, organisational reengineering and business improvement.

He is the Principal of Constellation group - a strategic advisory firm and is based in Sydney.

With the appointment of Byram Johnston as the new chairman, it is now appropriate for the current chairman to hand over to Byram and allow him to overlay his chairmanship regime and disciplines on the newly constituted board. Accordingly, I have retired from the board today. I have enjoyed seeing the company transition from Acuron Limited 2 ½ years ago to Greencap today – a vibrant national risk management group of over 420 staff across 16 offices supported by 1800 shareholders. I wish the new board every success for the future and enclose my App 3z.

Managing Director (MD)

As previously advised to the market, the first phase of Greencap's corporate strategy has been attained. The objective was to have an experienced corporate / M&A professional lead the company as Managing Director and assemble a group of highly regarded businesses in the risk management space to achieve a national service delivery platform.

Jeffrey Broun has capably lead the company over 2 ½ years and has overseen nine acquisitions in that time. In addition, Mr Broun has been intricately involved in all equity raisings and bank financing of such acquisitions.

The group is now to the stage of \$60 million pa in revenue, 420 staff with expansion into Asia.

The next phase for Greencap, as originally envisaged, is to recruit an industry experienced MD who can leverage the value within the group, maximising organic growth for shareholders. Greencap group has an extensive range of risk management services throughout its federated structure. An industry experienced MD driving the group business development strategy and coordinating the businesses for even greater service delivery should boost earnings and market profile.

Greencap is actively recruiting and we expect to have the new MD on board by May 2010. It is likely the new MD will be based in Melbourne or Sydney.

In the light of the board changes taking place and to facilitate the new structure Jeffrey will transition immediately from MD to corporate adviser to the group.

We appreciate Mr Broun's commitment to the company and to ensuring a smooth transition to the new MD.

On behalf of the board, I thank Jeffrey for his total commitment to the company over the past 2 ½ years. He was the co-creator of Greencap and his work and tireless energy in building the company to where it is today is most appreciated.

Greencap is extremely well placed to realise strong internal growth and I look forward to Greencap attaining its next objective – that of a \$100 million market cap status over the next couple of years.
