# 3. Change in relevant interests

The number of shares in which Fairstar has a relevant interest has reduced by 1,333,333 shares since the date of the last notice. These shares were transferred to vendors as part consideration for acquisition of mining interests-333,333 shares were transferred in August 2009 to satisfy consideration of \$100,000 and 1,000,000 shares were transferred in October 2009 (as announced on 1 October 2009) to satisfy consideration of \$370,000. These disposals resulted in a decrease in Fairstar's interest in GWR by approximately 0.9%.

The relevant interest stated in the notice dated 27 July 2009 was based on the then issued capital of GWR of 143,135,763 shares. As a result of a share placement by GWR on 1 July 2010 the issued capital has increased to 164,606,127 resulting in a dilution of Fairstar's interest in GWR by approximately 2.1%.
