Placement to Asian based Corporation, Australian Institutions and Sophisticated Investors

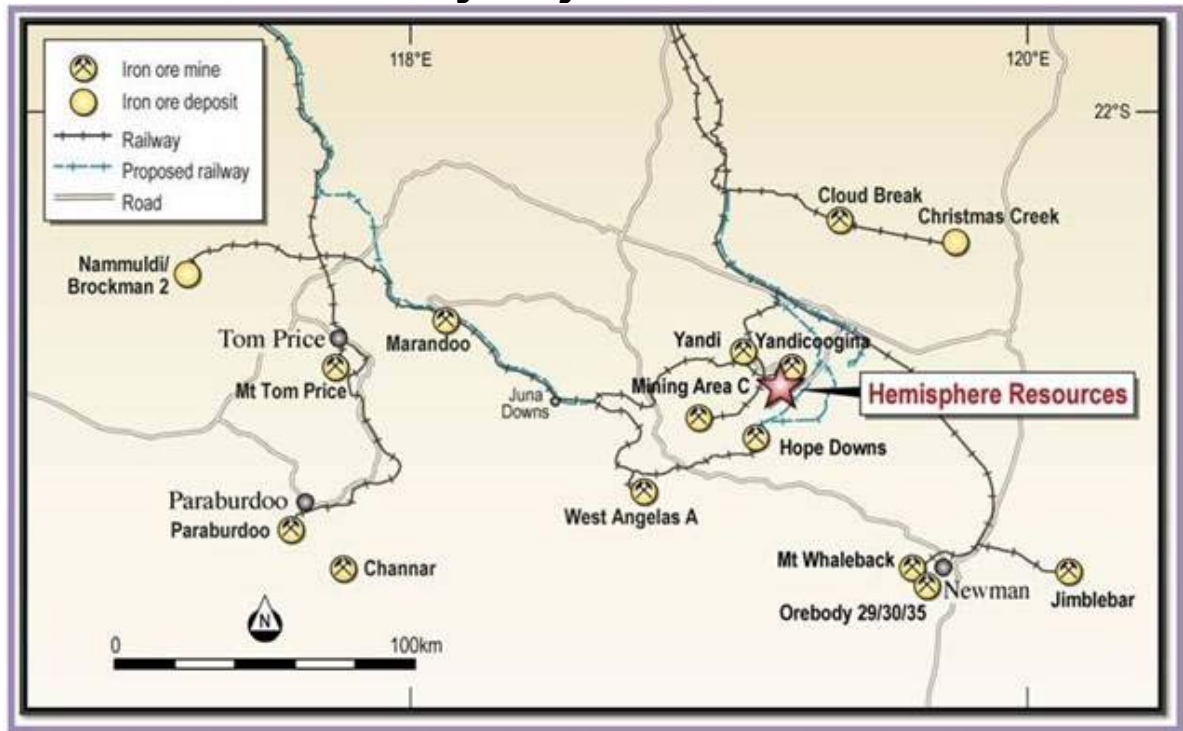
