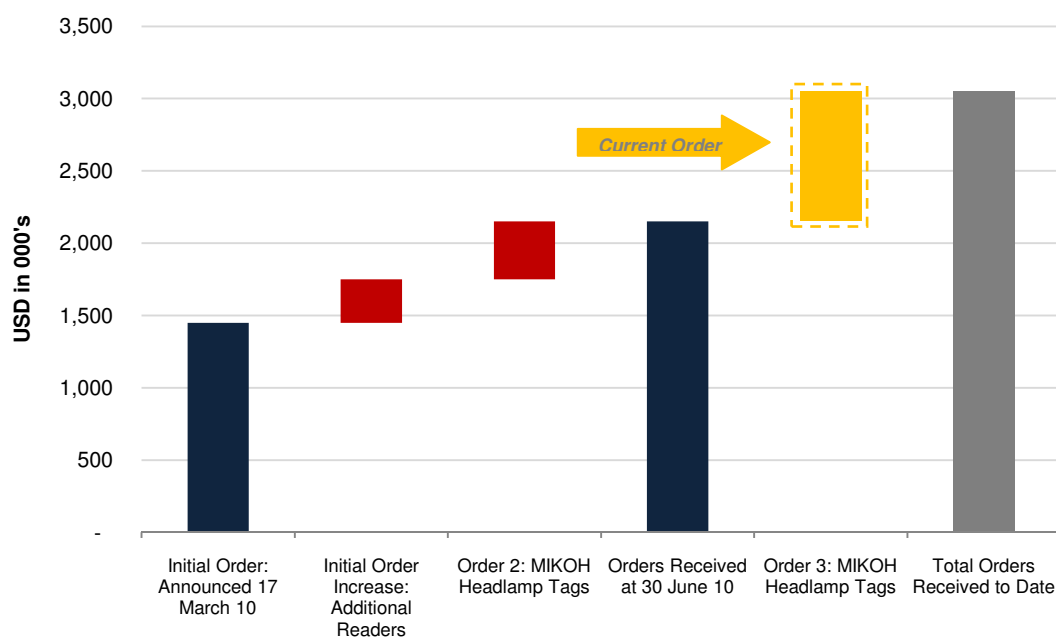
MIKOH Receives Third Additional Thailand Electronic Vehicle Registration (EVR) Order

Key points:

- **An order of US\$900,000 has been received for MIKOH's headlamp and decal tags under the Thailand EVR contract**
- **This third purchase order brings total orders received to date to US\$3.05 million, a further acceleration to the project's planned phased roll-out at this time**
- **Gross cash receipts received to date under the contract total US\$452,770**

Global securities solutions provider MIKOH Corporation Limited (ASX Code: MIK) today announced a further purchase order of US\$900,000 through its Electronic Vehicle Registration (EVR) system contract in Thailand.

The order comprised 1,000,000 MIKOH patented Smart&Secure™ 'destruct on removal' tamper evident RFID headlamp tags and 1,000,000 UHF decal tags to be delivered during September and October 2010. This represents a further acceleration to the original planned phased roll-out in Thailand envisioned under the contract and brings the total orders received to date to US\$3.05 million (*see graph below*).





Additionally, MIKOH announced that it has received cash payments to date totaling USD\$452,770 under the Thailand contract.

MIKOH's Chief Executive Officer, Dr. Paul Scully-Power said that the progression of the Thailand EVR system (now named 'SmartRFID' by the Thai Government) was very positive, and emphasises MIKOH's transitioning to a fully operational security solutions provider.

"MIKOH has now received purchase orders that will result in revenue that exceeds the likely full year revenue result for FY10. At such an early stage of FY11, this positions MIKOH for a most successful financial year and the new management team is focused on delivering superior results", said Dr Scully-Power.

"We are pleased with the substantial progress that has been made on the SmartRFID system and the tremendously successful sales and marketing campaign that has been launched to promote the benefits of SmartRFID to motorists in Thailand" said Hans van Pelt, MIKOH's Chief Operating Officer Asia-Pacific.
