The Maryborough Sugar Factory Limited - Notice in respect of Placement

As foreshadowed in its announcement on 14 December 2010, The Maryborough Sugar Factory Limited (“MSF”) today issued 8,025,831 fully paid ordinary shares (“Shares”) at an issue price of A\$3.15 per Share to sophisticated, experienced and professional investors who subscribed for Shares under the placement on Monday 13 December 2010.
