I am pleased to invite you to participate in the Nido Petroleum Limited (**Nido**) Share Purchase Plan offer (the **SPP Offer**) to raise up to \$10 million. The SPP Offer provides each eligible shareholder with an opportunity to apply for up to \$15,000 of new fully paid ordinary shares in Nido without paying brokerage or other transaction costs, on the terms and conditions of the SPP Offer.

On 28 October 2010, Nido announced that it had completed a \$19.875 million share placement (**Placement**). The SPP Offer provides eligible shareholders with an opportunity to participate in the equity raising by Nido at a price that is equal to the issue price under the Placement.

Participation in the SPP Offer is optional and open to eligible shareholders who, as at 5.00pm (AWST) on 26 October 2010, were registered as holders of fully paid ordinary shares in Nido and whose address on the share register is in Australia or New Zealand. The SPP Offer is also being extended to eligible shareholders who are custodians to participate in the SPP Offer on behalf of certain beneficiaries on the terms and conditions of the SPP Offer.

Purpose of the SPP Offer

The proceeds from the SPP Offer are intended to be used to secure Nido's future exploration program, including the drilling of the Gindara and Aboabo prospects, for general working capital and partial debt reduction.

Key elements of the SPP Offer

The SPP Offer price per share will be \$0.125 (12.5 cents), being the issue price under the Placement.

Eligible Shareholders (as defined below) of Nido Petroleum Limited (ACN 086 630 373) (**Nido**) each have the opportunity to participate in the Share Purchase Plan offer (**SPP Offer**) by subscribing for up to \$15,000 of new fully paid ordinary shares in Nido (**New Shares**) at the SPP Offer price without incurring brokerage or other transaction costs. Who is an Eligible Shareholder?

You are eligible to participate in the SPP Offer (an **Eligible Shareholder**) if you were a registered holder of fully paid ordinary Nido shares (**Shares**) at 5.00pm (AWST) on 26 October 2010 (the **Record Date**) with an address on the share register in Australia or New Zealand, subject to the terms and conditions of the SPP Offer. Nido has determined that it is not practical for holders of Shares with addresses on the share register in other jurisdictions to participate in the SPP Offer. See "Foreign securities restrictions" below for more information on restrictions on participation.

How much can Eligible Shareholders apply for under the SPP Offer?

Each Eligible Shareholder may participate in the SPP Offer by applying for one of the following amounts of New Shares from a minimum of \$2,000 worth of New Shares up to the maximum of \$15,000 worth of New Shares (subject to scale back) (**Share Parcels**):

Participation by Eligible Shareholders

from the requirement to hold an Australian financial services licence for the provision of a custodial or depositary service; or

- you are a trustee of a:
 - self-managed superannuation fund as defined in section 17A of the Superannuation Industry (Supervision) Act 1993 (Cth); or
 - superannuation master trust as defined in ASIC Class Order [CO 09/425]; or

Applicants should be aware that financial institutions may implement early cut off times with regards to electronic payments and therefore should take this into consideration when making payment. Applications may be scaled back

Nido is seeking to raise up to \$10 million under the SPP Offer. Proceeds from the SPP will be capped at \$10 million and Nido will scale back applications on a pro rata basis if they exceed \$10 million in aggregate.

If there is a scale back you may receive less than the parcel of New Shares for which you have applied. If a scale back produces a fractional number of New Shares when applied to your parcel, the number of New Shares you will be allocated will be rounded down to the nearest whole number of New Shares.

In the event of a scale back, the difference between the application monies received, and the number of New Shares allocated to you multiplied by the SPP Offer price, will be refunded to you.

Offer price

You should note that Nido's Share price may rise or fall between the date of this SPP Offer document and the date when the New Shares are allotted and issued to you under the SPP Offer. This means that the price you pay per New Share pursuant to this SPP Offer document may be either higher or

lower than the Nido Share price at the date the New Shares are issued and allotted to you under the SPP Offer. Please refer to the information under "Participation is optional" about how to monitor current trading prices of Nido Shares.

Calculation of the number of New Shares to be issued to you

In the absence of scale back (or any of the circumstances specified on page 6 under "How to apply for New Shares under the SPP Offer") the number of New Shares to be issued to you will be calculated by dividing the application money that you pay by the SPP Offer price, with any resulting fractions of a New Share being rounded up to the nearest whole number of New Shares.

Allotment and trading dates

New Shares are expected to be allotted under the SPP Offer on 1 December 2010 and are expected to commence trading on ASX on 3 December 2010.

Nido expects to dispatch a confirmation of allotment in respect of any New Shares allotted to you under the SPP Offer on 3 December 2010. You should confirm your holding before trading in any New Shares you believe have been allotted to you under the SPP Offer.

Foreign securities restrictions

To the extent that you hold Shares on behalf of another person, it is your responsibility to ensure that any participation complies with all applicable laws.
