### **SUCCESSFUL COMPLETION OF RIGHTS ISSUE**

Outback Metals Limited (ASX Code:OUM) (**OUM**) is pleased to announce the successful completion of the 1 for 3 non-renounceable rights issue (**Rights Issue**) that was announced to the market on 17 May 2010 seeking to raise approximately \$1.15 million.

As a result of the Rights Issue, a total of 57,921,902 new shares have been issued by OUM increasing the total number of fully paid ordinary shares on issue to 231,687,609.

As explained in the offer memorandum, the net proceeds of the Rights Issue will be used to fund the Company's continuing exploration activities and supporting administration costs.

Holding statements for the new ordinary shares issued under the Rights Issue are being despatched today with normal trading of the new shares to commence on the ASX from Monday 21 June 2010.
