On 25 February 2010, Outback Metals Limited (**OUM** or the **Company**) announced a proposed rights issue, on a one for one pro rata non-renounceable basis, to raise up to \$4.99 million (the Offer).

Since that announcement, the Company has finalised the timetable of the Offer and the closing date is now 29 March 2010 and securities to be quoted on a deferred settlement basis on 30 March 2010.

The revised Offer timetable is attached. The Offer document and application form is being mailed out to shareholders today.
