Re-quotation Disclosure

I refer to your correspondence of 10 September 2010 and confirm:

QED Occtech Limited (the Company) has completed the acquisition of Transaction Solutions International PLC (TSI) and issued 1,206,185,807 new shares to the TSI vendors. Pursuant to the agreement to acquire the TSI shares, the new shares in the Company are subject to voluntary escrow for a period of six months from the date of issue. This voluntary escrow will end 25 February 2011.

The Company has issued and allotted 78,300,000 fully paid ordinary shares at a price of 4 cents per share to sophisticated and professional investors. The Company has received \$3,132,000 from this capital raising.

A distribution schedule for the holders of ordinary shares and a listing of the 20 largest shareholders are provided separately.

The Company is in compliance with the Listing Rules and in particular its continuous disclosure obligations under Listing Rule 3.1.
