As previously disclosed in February 2009 the company increased its overdraft facility to A\$3,000,000 from A\$1,250,000. And on 08 December 2009, its overdraft facility was increased by its banker from A\$3,000,000 to A\$6,000,000. And on 22 February 2010, the company secured a new commercial bill facility for A\$7,500,000 from its banker while its overdraft facility was decreased by its bank from A\$6,000,000 to A\$3,000,000.
