## WOOLGAR GOLD PROJECT - QUEENSLAND STRATEGIC MINERALS CORPORATION NL - 100%

Strategic Minerals is pleased to advise that arrangements have now been finalised for the initial work program to be undertaken over the company's Woolgar project in Central North Queensland.


The initial program will start this week and includes mapping of the old Woolgar workings area, and paragenetic and structural geology studies of the Woolgar area followed by soil sampling and a drilling program.

The drilling program will initially be focused on the Mowbray area where promising high grade gold intersections were encountered from drilling activity conducted in 2008/9. Significant intersections from the previous drilling on the Big Vein structure at the Big Veins North prospect included; 5m @ 39.3 g/t gold (2008 drilling), 10m @ 5.14 g/t gold (2009 drilling), and 7m @ 2.45 g/t gold (2009 drilling). Additionally an intersection at the Mowbray NE prospect of 17m @ 1.34 (2009 drilling), is located more than 1.5kms further to the North and is also thought to be part of the Big Vein structure.(refer ASX release 30th April 2010).

The planned program includes drilling on the Big Vein structure to determine the full extent of the gold mineralisation both along strike and down dip. This is proposed to be a much more intensive drilling program that the previous exploratory drilling and allows for better delineation of the extent of the gold mineralisation around an area that now contains a number of very significant intersections.

The drilling program will also include additional targets determined from the mapping and soil sampling programs outlined above, and by a review of previous drilling in the Sandy Creek area.
