Tiaro completes \$3.4 million placement

Tiaro Coal Limited **(Tiaro)** (**ASX: TCM**) advises that is has completed a placement of 10 million fully paid ordinary shares at 34 cents per share to sophisticated, eligible and/or professional investors, as defined under Section 708 of the Corporations Act, raising \$3.4 million before costs.

Tiaro welcomes 80 new shareholders; a list of the names of Tiaro's twenty largest shareholders and a distribution schedule is attached.

The shares have been issued to clients of Patersons Securities Limited with strong participation by institutional funds.

Tiaro is currently drilling its T3 target and will continue its exploration program for the remainder of 2010.

The funds raised will allow Tiaro to accelerate exploration at its Tiaro Coal Measures Metallurgical Coal Project in South East Queensland and will also provide funds for general working capital.

Background

Tiaro's business objectives:

- To undertake exploration for commercially viable coal deposits with the potential to produce thermal export and domestic use coals as well as metallurgical (coking, PCI) coals from the Tiaro Coal Measures.
- To develop a substantial volume of export trade in bulk commodities in partnership with China Qinfa Group.
