Transit "Iron Ore Strategy" to Exploit Full Potential of Haematite Direct Shipping Ore (DSO) and Magnetite Prospects

- Assessment of magnetite and haematite potential at Johnston Range
- Appointment of Jon Lea to drive the Company's iron ore strategy

The Board of Transit Holding ("Transit" and ASX: TRH) is pleased to advise that the Company has commenced a formal programme to review the commercial opportunity presented by Transit's large and prospective iron ore assets in the Johnstone Range, West Australia.

Transit holds over 200km² of Exploration Licences at Johnston Range containing a 35 kilometre long sequence hosting multiple banded iron formations.

Increasing activity in the Yilgarn Iron Ore Province ("YIOP") has lead to the recognition that the region is an emerging iron ore province. This factor, along with recent corporate and exploration successes in the YIOP combined with continuing strong appetite for iron ore feed for the Chinese steel industry, has encouraged the Board to investigate strategies to unlock shareholder value in the Company's expansive and highly prospective iron ore leases.

Appointment of Iron Ore CEO

An integral part of the Company's move to assess the value of its iron ore assets is the appointment of

Jonathan Lea to drive forward Transit's iron ore strategy. Jon has qualifications in geology and mineral

economics with 25 years experience in the international resource industry.

He held the roles as Technical Director and Managing Director of Polaris Metals Ltd until the takeover by

Mineral Resources Ltd. During Jon's tenure Polaris made significant discoveries in the YIOP of haematite/goethite mineralisation, commencing the development process towards mining and also

advancing the Mayfield magnetite project.

Comprehensive Exploration programe planned

It is the Company's intention to fund an exploration programme including a major drilling component

and metallurgical testwork in order to establish a significant maiden inferred JORC compliant magnetite

resource. Following a review of funding requirements and options available to the Company, the Board

will shortly advise shareholders of its proposed strategy.

Exploiting the potential of the region

The Yilgarn is a proven haematite direct shipping ore (DSO) region with many exploration and

production successes. However the province is also being increasingly recognised as having potential

infrastructure benefits that suit larger magnetite plays. The main benefit is access to open access railway lines which connect to the ports of Esperance and Kwinana. This rail line is approximately 130km from

the Company's key iron ore exploration area.

A number of emerging magnetite projects are gaining momentum in the area with the following

In addition recent field work aimed at ground truthing targets delineated from assessment of gravity and magnetic geophysical surveys has generated significant exploration potential for haematite. The province is estimated to contain over 250mt of haematite DSO. In 2008 Cliffs completed a takeover of Portman Ltd and currently produces 8mtpa. In 2011 Mineral Resources Ltd (who took over Polaris Minerals NL in 2009) and Cazaly Resources plan to start producing DSO and to export it through Kwinana.
