## SUBJECT: RESPONSE TO TRANSERV ENERGY LIMITED PRICE AND VOLUME QUERY

In response to your query dated 23 March 2010, please see below;

1. The Company does not believe there is any unannounced information concerning it that would explain the recent increase in trading volume in the Company's securities.

We note the strong general investor and market interest in unconventional gas plays, including tight sands, coal bed methane and shale gas, has increased substantially in recent times. Transerv's Warro project is the leading unconventional gas play in the Western Australia market. As previously announced, the joint venture is completing the technical studies on the Warro project with US based tight sand experts, which involves planning and design work for the drilling of the Warro 4 appraisal well in 2010, and undertaking a 3D seismic survey.

The technical studies are now largely completed and planning of the Warro 4 and the 3D seismic survey is now well advanced. A further announcement will be made upon completion of scheduling of the Warro 4 well.

## Trading halt

If you are unable to respond by the time requested, or if the answer to question 1 is yes and an announcement cannot be made immediately, you should consider a request for a trading halt in the company's securities. As set out in listing rule 17.1 and the guidance note titled "Trading halts" we may grant a trading halt at your request. We may require the request to be in writing. We are not required to act on your request. You must tell us each of the following.

- The reasons for the trading halt.
- How long you want the trading halt to last.
- The event you expect to happen that will end the trading halt.
- That you are not aware of any reason why the trading halt should not be granted.
- Any other information necessary to inform the market about the trading halt, or that we ask for.

The trading halt cannot extend past the commencement of normal trading on the second day after the day on which it is granted. If a trading halt is requested and granted and you are still unable to reply to this letter before the commencement of trading, suspension from quotation would normally be imposed by us from the commencement of trading if not previously requested by you. The same applies if you have requested a trading halt because you are unable to release information to the market, and are still unable to do so before the commencement of trading.
