NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT 2001

This notice is given by Adelaide Energy Limited (ACN 116 256 823) ("ADE") pursuant to section 708A(5)(e) of the *Corporations Act 2001* (Cth) ("the Act").

As announced to the ASX today, ADE has completed a further share placement with Beach Energy Limited. The company has received funds for 59.5 million fully paid ordinary shares at \$0.165 per share (total \$9,817,500).

In accordance with section 708A(5)(e) of the Act, ADE give notice that:

1. ADE has issued the above shares ("**New Shares**") without disclosure to investors under part 6D.2 of the Act.
