#### NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT 2001

This notice is given by Adelaide Energy Limited (ACN 116 256 823)("ADE") pursuant to section 708A(5)(e) of the *Corporations Act 2001* (Cth)("the Act").

As previously announced to the ASX on 13 April 2011, the Company is completing a share placement with sophisticated investors. The company has received funds for 19 million fully paid ordinary shares at \$0.14 per share (total \$2,660,000).
