Capital Raising

The Company has completed a placement of 133,890,649 ordinary shares in August 2011 at an issue price of A\$0.003 per share. This amounts to A\$401,672.00 in net proceeds to the Company.

As announced to the market today, the Company has further secured a converting loan of \$526,892.70 in September 2011.
