### MADAGASCAR HIGH GRADE GOLD SAMPLE CONFIRMED

Cluff Resources Pacific NL (Cluff) announces that ALS Laboratories in Perth has confirmed a high grade gold result in the first analysed samples from the 565 kg of material recently extracted from the company's joint venture permit in Madagascar and shipped to Perth for detailed analysis.

The attached certificate discloses gold assays in this sample of between **16.50 grams per tonne (g/t)** and 9.04 g/t whilst **the average grade is 12.30 grams per tonne**. These analyses represent a subsample of part of the bulk material collected from the project area as described in the ASX release dated 16 February 2011.

Cluff Chairman Peter Ashcroft stated: 'We are very excited with this result, which confirms the enormous potential of this project'.

Cluff is proceeding to have Ammtec complete a detailed analysis of the entire sample, which will include a report into the best processing methods to ensure effective and good commercial recoveries. This report should be available before the end of the month.

The extracted gold sample was excavated from shallow shafts 10 to 12 metres beneath the surface and presents a tremendous opportunity to prepare that part of the deposit close to the surface for immediate trial mining.

Cluff is currently finalising plans and the contract for a trial mining program for 100 to 150 metres north from the location of the sample for the next 3 months, to stockpile material and begin confirming the extent and grade of the deposit by regular interval sampling. Local artisanal miners, who have been excavating the target zone by hand over 1.5 kilometres for the past 12 months, have now been moved off the permit. At the conclusion of the trial mining Cluff intends to undertake an extensive drilling program to delineate the extent of economic mineralisation.

This project is held in joint venture with Varun International. The joint venture holds a current Exploitation Licence over the project area and provides for a production share of all gold produced on the permit of 35% to Cluff and 65% to Varun.

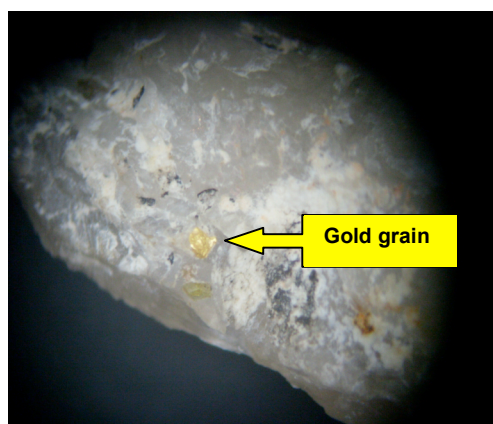

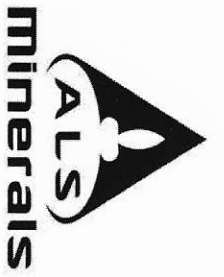

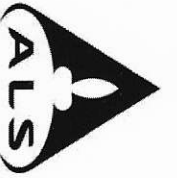
