I refer to the appointment of Bradley Tonks and I as Joint and Several Administrators of the Company and its subsidiary, Data 1 Pty Ltd, on 30 June 2011 ("the Companies").

At a meeting of creditors of the Companies held concurrently on 15 November 2011, creditors resolved that the Companies execute Deed of Company Arrangements ("DOCA") under Part 5.3A of the Corporations Act 2001 ("the Act").

The DOCA's were executed by the Companies and Core Equities Pty Ltd ("Core Equities") on 6 December 2011 and Bradley Tonks and I were appointed Joint and Several Deed Administrators of the Companies.

I note that the DOCA's will be lodged with the Australian Securities and Investments Commission in accordance with Section 450B of the Act.

Under the DOCA's, control of the Companies will remain with our office until a shareholders meeting for Connxion is held, which Core Equities expect to convene within eight (8) to ten (10) weeks.
