### FORM 605 CEASING TO BE SUBSTANTIAL HOLDER

European Gas Limited (the Company) advises that 22 million shares issued as part of the restructuring of the 'Transcor Convertible Notes', which had a voluntary escrow applying to them and which were subject to a Restriction Agreement are now fully tradable.

The Company as a party to the Restriction Agreement had a 'relevant interest' in greater than 5% of its own shares and as a consequence was required to complete a Form 603 'Notice of Substantial Holder'. As a result of the expiry of the trading restriction on these shares the relevant interest no longer exists.
