#### Sub: Invitation to Gujarat NRE Longwall Open Day on 9<sup>th</sup> October 2011

I am pleased to inform you that Gujarat NRE Coking Coal Limited is in the process of reintroducing longwall mining at its NRE No. 1 Colliery at Russell Vale. As you may be aware, we had placed an order for longwall machinery, valued at \$90 million, with Joy Manufacturing Company. You would be happy to note that the first batch of longwall equipment is ready for commissioning as per schedule.

The world economy seems to be in the grip of fear of another recession, with the current Eurozone crisis and the manufacturing stagnancy world over, be it in China and India or in the USA and Australia. The recent global economic conditions have been dampening spirits and investor sentiments from which no one can claim immunity.

However the golden lining lies in the fact that in our industry, if winter is here, spring cannot be far behind. The company is preparing itself to reap the boom of the sunny days which can not hide long behind the twilight. Gujarat NRE is increasing its coking coal production in its Australian mines to reach the production target of 6 MTPA by 2015. The proposed introduction of longwall mining at our No. 1 Colliery at Russell Vale is a step in this direction, which would alone take the production of coking coal from NRE No 1 mine to around 3 MTPA by 2015.

The Longwall open day at NRE No. 1 Colliery will showcase the longwall machinery on the surface prior to its commissioning underground. This will provide visitors with a real-life simulation of one of the most modern longwall systems available globally.

I look forward to your continued support and confidence in the company as well as your long term association as a valued investor.
