AUSTRALIA UPDATE: PEP 167 PROJECT STATUS

Interra Resources Limited (the "Company" or "Interra") refers to the announcement on 29 November 2010 (the "Announcement") with regard to the PEP 167 joint venture plans to drill a new well to follow up on the 1987 Windermere-1 oil discovery in the onshore Otway Basin, near Portland, in Western Victoria.

Further to the Announcement, the Company wishes to inform shareholders that, in view of the wet conditions attributable to unseasonable weather around the well location and to avoid the adverse weather during winter in the area of Otway Basin, the PEP 167 joint venture is now planning to drill the new well (Windermere-3) in the fourth quarter of 2011, instead of second quarter of 2011 as previously announced.

The Company wishes to advise that investors should exercise due care and caution when trading Interra's shares. It is not certain that the drilling mentioned above will ultimately yield commercially recoverable hydrocarbons or profitable production.
