Dear Shareholder,

The Directors of LaserBond are pleased to announce that the fully-franked dividend for the full year ended 30 June 2011 of 0.5 cents per share was paid to shareholders today.

LaserBond also advises that 1,164,446 new shares were issued today in lieu of cash dividends to participants in the Dividend Reinvestment Plan ('DRP'). The shares were issued at \$0.1350 per share, representing a 5% discount to the 5 day volume weighted market price following the Dividend Record Date, calculated in accordance with the DRP Terms and Conditions.
