Exploration

Newland Resources Limited (Newland) is pleased to announce that it has commenced drilling at the Comet Ridge Project (EPC1230) south of Comet in the Bowen Basin.


The Comet Ridge Project has the potential to host shallow deposits of open pit coking and export thermal coal that are located adjacent to existing rail line access to Gladstone from Emerald and Rolleston.

Newland expects (weather permitting) to have the initial 19 hole drilling program completed by the end of February, and have drilling results and coal analysis data from this program by late March 2011. The location of holes in the proposed program is illustrated on page two.

To date, six holes to depths of between 90 and 150 metres have been completed in the south eastern sector of the tenement. A consistent stratigraphy has been observed and seams intersected are believed to correlate with the Fair Hill and Burngrove measures, along strike from Stanmore Coal's McKenzie River Project coking coal resource.

Geological work is continuing on all other Newland projects in the Bowen Basin in advance of the planned exploration activities in 2011.
