Phosphate Drilling Begins at Arganara in the Northern Territory

NuPower is pleased to announce that reverse circulation (RC) drilling on its Arganara Phosphate Project in the Northern Territory will begin today. NuPower plans to drill approximately 200, 30m holes for a total of 6000m of drilling over the next 5 weeks. The aim of this initial program is to both define a phosphate footprint and continue a 200x200m spaced grid of holes covering known phosphate mineralisation on an adjacent tenement, which may be interpreted to extend onto NuPower's ground.


Preparations over the last few weeks have included grading access tracks and general site preparation for drilling, along with establishment of a fully equipped field camp including a telecommunications block, kitchen and other amenities. NuPower expects to be working at Arganara for some time because of the potential of the prospect, based on its close proximity to known phosphate resources and position along strike from historic phosphate occurrences at Anomaly L and Limestone bore further to the north east and east, and also located on the wholly owned Arganara exploration license (EL 24726).

Analysis on drill chips will begin shortly, with samples to be transported to Alice Springs every 4 to 6 days for preparation before being sent to ALS in Brisbane for analysis.

If the potential is confirmed, NuPower aims to become a significant phosphate company through development of its Arganara and separate Lucy Creek Projects in the Northern Territory of Australia.
