Arganara Phase 2 Drill Program Approved Drilling Will Commence Immediately




Figure 1: NuPower's Arganara Exploration Licenses (EL's) 24726, 27987 and 25664 shown in black.

NuPower is pleased to announce that a Phase 2 reverse circulation (RC) drill program has been approved on its Arganara Phosphate Project in the Northern Territory. The Phase 2 program will include approximately 166 additional 30m holes for 4980m of drilling. The aim of this program is to extend the phosphate footprint and test if mineralisation is continuous from Arganara to Limestone Bore (approximately 30km in strike length, see Figure 1).

The Phase 1 program is nearly complete with just the western detailed 200x200m spaced grid of holes covering possible extensions of known phosphate mineralisation on an adjacent tenement, yet to be completed.

NuPower expects the Phase 2 program to be completed quickly, as it will follow directly on from the Phase 1 program and utilise the existing field camp and drill rigs. If time and weather permits, the Phase 2 drill holes planned at Anomaly L will also be completed, however, if not completed this year, then they will be drilled separately during 2012.

Currently Phase 1 drill chips are being submitted to ALS in Alice Springs for preparation before being sent to ALS in Brisbane for analysis. Unfortunately there have been some delays with initial batches. NuPower hopes delays will not extend into the second phase of drilling.

NuPower aims to become a significant phosphate company through development of its Arganara and separate Lucy Creek Phosphate Projects in the Northern Territory of Australia.
