## RIVERCITY MOTORWAY GROUP (ASX:RCY) APPOINTMENT OF VOLUNTARY ADMINISTRATOR

The Directors of RiverCity Motorway Group (ASX: RCY) today announced the appointment of Michael Owen, Stephen Parbery and Christopher Hill of PPB Advisory as Voluntary Administrators of all entities within the RiverCity Motorway Group as indicated in **Schedule 1 and Schedule 2**.

The appointment of Voluntary Administrators was taken after the failure of the Group's debt syndicate to unanimously approve a financing repayment standstill agreement that was due to be finalised at close of business Thursday 24 February 2011.

Although the Group had approximately \$101m in cash at 31 December 2010, without a suspension of financing repayments for the foreseeable future, the Group is unlikely to have adequate time to improve its operating cashflows to support its ongoing debt repayments.

Subsequent to the appointment of the Voluntary Administrators, the Group's debt syndicate appointed Martin Madden and David Merryweather of KordaMentha as receivers to the entities as indicated in **Schedule 2**.

The operations of the CLEM7 tunnel and Flow Tolling business are unaffected by the Group's voluntary administration and appointment of the receiver and manager.
