NOTES TO THE US DOLLAR FINANCIAL INFORMATION RNY PROPERTY TRUST

For the half year ended 30 June 2011

1. BASIS OF PREPARATION

The additional US dollar information has been extracted from the consolidated financial report of RNY Property Trust for the half year ended 30 June 2011 before conversion to Australian dollars. Australian dollar denominated assets and liabilities have been translated from Australian dollars at the rate of exchange current at the balance date.
