NOTICE GIVEN UNDER SECTION 708A(5) OF THE CORPORATIONS ACT

This notice is given by the Company under section 708A(5)(e) of the Corporations Act in relation to the issue of 246,100,000 shares to sophisticated and exempt investors. The shares were issued under the Company's existing 15% placement capacity in accordance with ASX listing rule 7.1 and a Shareholder approval granted on 19 May 2011.

As at the date of this notice, the Company has complied with:

- (a) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
- (b) section 674 of the Corporations Act.
