Adslot signs new customer

- Adslot has executed a formal agreement with Realestate.co.nz.
- Adslot launches world first new premium listing product.

The Webfirm Group (ASX:WFM) subsidiary Adslot has entered into a commercial agreement with Realestate.co.nz Limited, a leading real estate portal in New Zealand.

Realestate.co.nz will be the first customer to use Adslot's technology to sell premium classifieds listings.

This new premium listing product is the first time Adslot has combined the Adslot sales and optimisation platform with the recently acquired QDC Adbuilder and Adimise ad server technologies.

In the near future Real Estate agents in New Zealand will be able to log into the Adslot platform, choose which listing to make premium and using a range of specially designed templates quickly create an effective and professional looking multimedia premium listing.

These new premium listings will be served by the fully integrated Adimise ad server, allowing significantly more display options for both the Agents and Realestate.co.nz.

Webfirm Group Chairman, Adrian Giles said, "This is a very significant win for Adslot as it is the first implementation of an automated self-serve sales solution for premium listings anywhere in the world."
