Off-market takeover bid by Westgold Resources Limited for Aragon Resources Limited Close of Offers

Westgold Resources Limited 60 009 260 306 (**Westgold**) advises that the off-market takeover bid for all the fully paid ordinary shares (**Share Offer**) and issued options (**Option Offer**) in Aragon Resources Limited ABN 63 114 714 662 (**Aragon**) closed at 5.00pm (AWST) on 27 April 2011.

As the relevant thresholds in respect of both the Share Offer and Option Offer have been reached, compulsory acquisition of the outstanding Aragon shares and options will proceed.

Please find attached pursuant to section 662B of the Corporations Act 2001 (Cth) (**Corporations Act**) a copy of ASIC Form 6022 for both the Share Offer and Option Offer (Notice of right to buy out to remaining holder of securities following a takeover bid) (**Notices**).

As permitted under the Corporations Act, copies of the Notices will not be sent to any remaining Aragon securityholders entitled to receive the Notices as those remaining securityholders have been sent a notice of compulsory acquisition under section 661B of the Corporations Act.
