ASX Announcement Capital Raising

As such the Placement is not expected to have a dilutive effect on existing shareholders' interests. The estimated unaudited pre-tax NTA as at **3 May 2012** is \$0.90 per Share.

The funds will be used to opportunistically take advantage of current market conditions and secure additional fund investments.

It is anticipated that the Placement of these Shares will be completed and that allotment will occur by **16 May 2012**. The new Shares will rank equally with all ordinary shares currently on issue.
