Clean TeQ Awarded Significant Odour Control Contract

Clean TeQ Holdings Limited (**ASX: CLQ**) is pleased to announce the award of a significant contract for an Odour Control Facility (OCF) by Baulderstone Pty Ltd & United Group Infrastructure Pty Ltd trading as WRA BPL-UGI Joint Venture and on the behalf of Melbourne Water. The contract, to the value of \$2.75m, is divided into two separable portions; the first covering design and the second covering the procurement and construction of the OCF. The OCF will be located at the Eastern Drop Structure on the Hobson's Bay Sewer Line located below the Westgate Bridge. The design is due to be completed by the end of November 2012, with separable portion 2 expected to begin in October 2012 with completion in December 2013.

The facility will utilise Clean TeQ's proprietary OdourTeQ[®] biological air treatment technology. The award of this contract supports Clean TeQ's position as the market leader in biological odour control in Australia. It extends the relationship between Clean TeQ and Melbourne Water after the recent delivery of the OCF at Bass St in Pascoe Vale.

Peter Voigt, CEO Clean TeQ said: "Clean TeQ is again very pleased to be working with Melbourne Water to deliver this significant odour control project. Our association with Melbourne Water has been a long one since we first supplied an earlier version of the biotechnology at the South Drop Structure located in the grounds of Scienceworks back in 2000 / 2001. This project further reinforces our position as the leader in the biological odour control marketplace within Australia. The securing of this contract, along with others in the pipeline, will underpin our Air Divisions budget in 2012 / 2013. These projects also allow us to continue to grow our investment in people and technology, putting an Australian company at the forefront globally. This investment will provide us with a springboard into the rapidly growing markets in Asia and the Middle East."
