Completion of Share Purchase Plan

Entellect Limited (the **Company** or **Entellect**) advises that its recent partly underwritten Share Purchase Plan (**SPP**) which closed on 19 December 2012 has been successfully completed.

A total of \$369,570 (before expenses of the offer) has been raised under the SPP. The Company confirms that this total includes the underwritten portion of the SPP, of which a majority has now been received by the Company with the balance expected to be received shortly.

A total of 144,785,000 shares have now been issued and allotted to shareholders who participated in the SPP, as well as to the underwriters of the SPP, reflecting the funds actually received by the Company, with a balance of 40,000,000 shares to be allotted shortly when the balance of the underwritten funds is received.

An Appendix 3B in relation to the issue of the SPP and underwritten shares allotted today will be lodged on the ASX following this announcement. An Appendix 3B in relation to the shares to be issued upon receipt of the balance of the underwriting is expected to be lodged shortly.

Effect of Rights Issue on Capital Structure

The Company confirms that pursuant to the allotment of the SPP and underwritten shares earlier today, there are 1,130,122,932 fully paid ordinary shares on issue.

A statement setting out the names of the current 20 largest holders of fully paid ordinary shares and the percentage held by each, together with a current range of units report, is attached to this announcement.
