Please find attached an Appendix 3B in relation to the issue of 36,080,332 shares in Hot Rock Limited (HRL) to raise approximately \$541,000.

The shares have been issued in accordance with the Shortfall provisions included in the recent Rights Offer, that closed on 31 August 2012, which provided that in the event that there is a Shortfall in subscriptions under the Offer, the Directors had the right, as contemplated within the Listing Rules, to allocate any Shortfall of New Shares at their discretion so as to ensure a maximum amount of funds are raised.

The \$541,000 is in addition to the funds raised from existing shareholders of approximately \$922,000 (for which the shares were issued on 17 September) to give a total amount raised under the Rights Offer of \$1.463 million.
