Appendix 3B – New Issue Announcement

LaserBond announces that 200,000 shares have been issued today pursuant to the conversion of convertible notes to the value of \$30,000. This leaves an outstanding balance of convertible notes to the value of \$210,000.

By way of explanation, in April 2010 when LBL shares were trading on market at close to 7c, unsecured convertible notes were issued with a face value of \$350,000 to provide additional working capital for the group. The repayment date of the notes is 30 June 2012. However, in the interim they are convertible into ordinary fully paid shares at an issue price determined as the lesser of 15 cents per share or 85% of the weighted average market price of the company's shares over the last 5 days on which sales were recorded before the date of conversion and issue. So far notes to the value of \$140,000 have been converted, leaving the balance of \$210,000.

Shares issued upon conversion carry standard rights applicable to quoted ordinary shares in the company and will, from the date of issue, rank equally with fully paid ordinary shares currently on issue.

Until converted, interest on notes is payable quarterly in arrears at 9.5% per annum. The notes do not provide for any voting rights at shareholder meetings of the company. They are unsecured and the holders rank equally with all other unsecured creditors. Unless converted in the interim, the outstanding notes will be repaid on the repayment date at the face value.
