MRC ANNOUNCES SIGNING MINING CONTRACTOR

Mongolian Resource Corporation Limited 'MRC' (the Company) is pleased to announce that it has signed a contract with Philippines mine contractor, Paramina Earth Technologies Inc. (Mining Division) to undertake contract mining at its two mine sites in Mongolia. The contract will provide the experience and manpower for MRC to reach its underground production targets from the high grade narrow underground mines of Sujigtei and Blue Eyes.

Paramina Mining are one of the world's premier mining contractors specialising in narrow handheld mining and have the resources to undertake any scale of mining. Currently they operate 4 underground mines outside the Philippines, in Vietnam, Tanzania and India and have more than 450 miners allocated to these projects.

By engaging such an experienced contractor the Company will ensure the risks of mine ore delivery are reduced as the Company gains experience to handle the operations. It is expected the total underground mining workforce to reach around 120 persons by the end of the year. The Company targets to increase production to 500 tonnes per day by first quarter next year.
