During the quarter Nickelore Limited (ASX: NIO) ("Nickelore") the board continued to keep a tight rein on spending while waiting for some stability in the Nickel price.

In addition to its cash reserves, the Company holds listed investments with a current market value of approximately \$523,000.

Activity on the Company's projects during the quarter is summarised below.

Nickel

The Company continues to review options in relation to its Nickel assets, including possible sale or development options. With the Nickel price once again on the improve, the Canegrass Project remains a valuable asset.

The Board has completed an evaluating of its tenements and has decided to focus its attention on tenements within the main tenement area. To this end, NIO will relinquish a number of outlying tenements considered of no value to the project in order to further reduce costs.

Other

The Directors of the Company continue to look for opportunities and projects internationally.
