

**ISSUE OF SUMATRA COPPER & GOLD PLC CDIs – SECONDARY TRADING NOTICE - NOTIFICATION  
PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")**

On 7 September 2012, Sumatra Copper & Gold plc ("**Company**") issued 28,000,000 fully paid CHESS Depository Interests (CDIs) at an issue price of \$0.135 each ("**Securities**").

**Secondary Trading Exemption**
