- Acquisition of the business, Absolute Liquid Waste Services (Absolute) based in Toowoomba,
 Queensland.
- Absolute is a leading provider of waste services to the Coal Seam Gas (CSG) sector in the Surat Basin, Queensland.
- Absolute provides Toxfree with a new geographic presence to complement Toxfree's existing services in Roma, Qld.
- Absolute has a waste services contract with QGC (part of the BG Group) for the management of effluent and production waste water from their CSG upstream drilling activities.
- Absolute is on track to achieve \$1.3M EBITDA. The acquisition price is \$4.9M including assets of \$2.5M, representing a 3.8 times EBITDA multiple.
- Toxfree expect to further develop this business which is leveraged to the growing Coal Seam Gas drilling activities in the Surat basin through additional waste management services.

The Board of Tox Free Solutions Ltd (Toxfree) is pleased to announce it has completed the acquisition of Absolute based in Toowoomba, Queensland.

The purchase price for the Absolute business is \$4.9M. Absolute is on track to achieve Earnings Before Interest, Taxes, Depreciation and Amortisation (EBITDA) of \$1.3M and is experiencing significant growth in the CSG sector west of Toowoomba. The value of Absolute's assets is \$2.5M which are included in the sale price.

The acquisition of Absolute provides Toxfree with access to Absolute's blue chip client base throughout the CSG sector in the Surat Basin, Queensland. Absolute has a long term contract with QGC to provide waste services for their upstream drilling campaign; services include the transport and disposal of liquid waste. The contract has a further two years to run, expiring November 2014.
