Jeff Williams Appointed as Non-Executive Director

World Titanium Resources Ltd (WTR) (ASX:WTR) is pleased to announce the appointment of Jeff Williams as a Non-Executive Director effective immediately. Jeff is the former Managing Director of Mineral Deposits Limited (MDL) and adds additional mineral sands development experience to the board, having been Managing Director of MDL during the development of the Grande Cote mineral sands project in Senegal.

Jeff established Nimbus Resources (now MDL) in 1997, and acquired mineral sands assets from BHP-Billiton near Hawks Nest on the New South Wales coast in 1998. He subsequently secured the Sabodala gold and Grande Cote zircon/ilmenite projects in Senegal in west Africa. Mr Williams was Managing Director of MDL until 2011.

Before establishing MDL Jeff spent 16 years as a professional mining engineer and seven years in the stockbroking industry. He is a Fellow of the Australasian Institute of Mining and Metallurgy and his mining experience ranges from mine planning, underground management and feasibility studies to mine development. From 1972 to 1984, he held various positions with CRA Limited at Broken Hill in New South Wales. Following completion of his Masters of Business Administration (MBA) programme in 1987, he played a major role as a Senior Project Engineer with North Limited. From 1989 to 1996, he specialised in gold mining research in the stock broking industry. Prior to establishing Nimbus Resources in 1997, he was the Head of Resources Research at James Capel Australia. Jeff is currently a Non-Executive Director of Archean Star Resources, MacPhersons Reward Gold Limited and A1 Consolidated Pty Ltd.

Commenting on the appointment, Executive Chairman Wayne Malouf stated "We are delighted that Jeff Williams has agreed to join the Board, he is an experienced mineral sands executive who has developed green field mineral sands assets in Africa. His appointment complements and builds upon the experience of the existing Board."

About World Titanium Resources

World Titanium Resources (ASX:WTR) is an Australian listed mineral sands company that owns 100% of the Tier 1 Toliara Sands Project in Madagascar including a current JORC Resource of 707Mt grading 6.5% total heavy mineral (THM) at Ranobe.

Phase 1 will focus on mining 145Mt grading 8.1% THM. Phase I is estimated to produce 400,000 tonnes of ilmenite and 43,000 tonnes of rutile/zircon concentrate per annum over an initial 20 year mine life.

The current JORC Resource at Ranobe can sustain a ~75 year mine life at the initial planned production rates. The Toliara Sands Exploration permits at Ranobe, Ankililoaka, Basibasy and Morombe contain a total exploration target in excess of 4,700Mt of ore.
