**BOARD RENEWAL AT AHL** 

The listed entertainment, hospitality and leisure operator Amalgamated Holdings Limited

("AHL") today announced current and proposed changes to the composition of the AHL Board.

Mr Tony Clark AM, an independent non-executive director of the Company, has indicated his

intention to retire at the 2013 Annual General Meeting. Mr Clark was appointed to the Board in

1998 and has served as the lead independent director, as well as Chairman of the Audit

Committee and Nomination and Remuneration Committee.

AHL Chairman, Mr Alan Rydge commented: "Mr Clark has been a committed Board member

since 1998 and has brought great diligence, care and focus to the Board's deliberations.

Tony's participation and contribution, including his Chairmanship of the Audit and Nomination

and Remuneration Committees, has been invaluable and the Group and its shareholders have

greatly benefited from Tony's experience, wisdom and professional approach. On behalf of the

AHL Board and Group, I express sincere appreciation to Tony for his contribution and

commitment and I wish him well for the future".

Following recommendations made by the Nomination and Remuneration Committee, the AHL

Board has today appointed Mr David Grant (B.Comm, CA, GAICD) as an independent non-executive

director. In addition, the AHL Board has announced that Mrs Patria Mann (BEc CA MAICD) will

stand for election as an independent non-executive director at the 2013 Annual General

Meeting.

Mr Grant is a Chartered Accountant and a director and chairman of the Audit and Risk

Committee of iiNet Limited, and was a founding director of New Zealand-based Trans-Tasman

Resources Ltd. Mr Grant's corporate experience also includes roles with Goodman Fielder

Limited, Consolidated Rutile Limited and Iluka Resources Limited.

Mrs Mann is a Chartered Accountant and was formerly a partner at an international accounting firm. Mrs Mann has extensive audit, investigation, risk management and compliance experience and is currently a director of Ridley Corporation Limited, First State Superannuation Trustee Corporation, The Doctors' Health Fund Pty Limited and Perpetual Superannuation Limited.

Mr Rydge commented: "It is pleasing to have identified two new candidates with the experience of Mr Grant and Mrs Mann, both of whom will be a valuable addition to the AHL Board."
